Dear Prospective Full Member:

Attached is an application form for full membership to the Ashtabula Yacht Club. You should follow these instructions and return the application to the Secretary without delay.

1. Completely fill out the form. Applicants must be sponsored by one AYC member in good standing.
2. An application fee of \$200.00 plus \$13.50 sales tax must accompany the application.
This fee is nonrefundable.
3. Upon approval of your application by the membership following publication in the newsletter, you will be billed by the Treasurer for the Initiation fee which is \$2000.00 plus \$135.00 sales tax which will entitle you to full voting privileges, or you may elect to pay your Initiation Fees in four annual installments of \$500 plus \$33.75 tax (after full payment of which you will have voting privileges).
This fee is nonrefundable.
4. The Treasurer will also invoice you for your membership dues, dockage, and assessments due at the time of your approval. The annual dues are \$785.00 plus \$52.99 sales tax and will be prorated based on the time of year of your application. Dockage is calculated at \$20.00 per foot and is not prorated.
5. All Applications must be accompanied by proof of ownership/registration and insurance.
6. Applications for Full Membership may be submitted before owning a boat: such applicants will leave those portions of the application blank.

By his or her signature, the applicant acknowledges that the AYC Board of Governors has complete discretion on the admittance or denial of any membership applications and that there is a onetime non-refundable initiation fee in the amount of \$2,000.00 plus sales tax, of which the sum of \$200.00 plus \$13.50 tax = (\$213.50) must be paid with this application and the remaining fees will be invoiced within 15 days of acceptance. All docks are assigned on the basis of seniority and other factors and the BOG cannot guarantee any new member a dock assignment. Winter storage of vessels is allowed only upon admittance into the Club and full payment of initiation fees and annual dues.

The applicant further agrees to be bound by the terms and conditions of the AYC Constitution, its Bylaws and regulations, and the rules and regulations promulgated by the Board of Governors.
